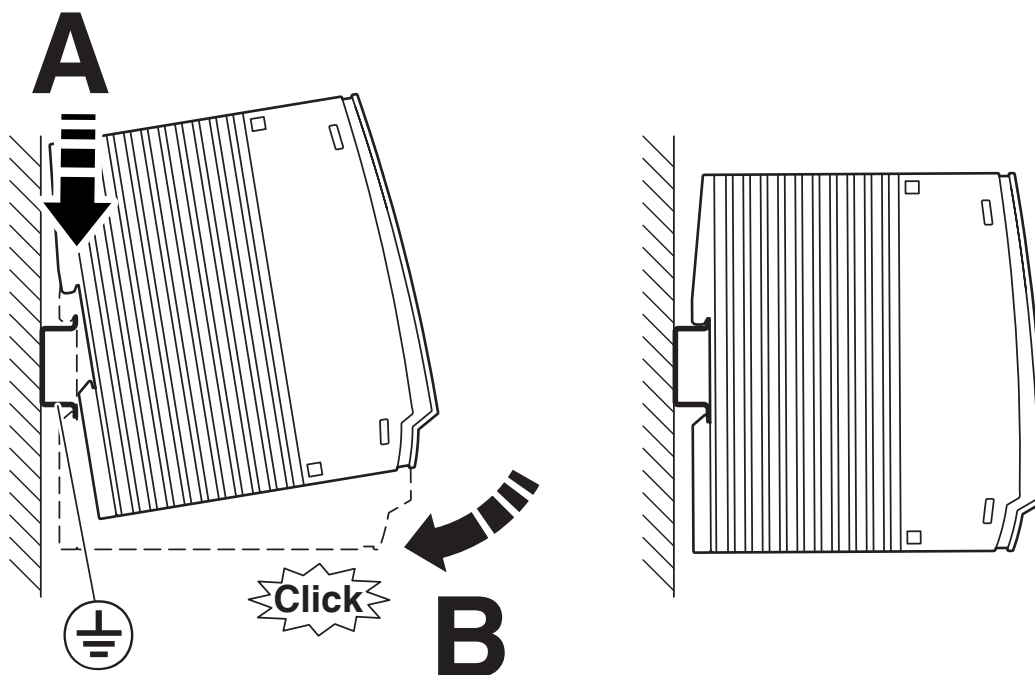

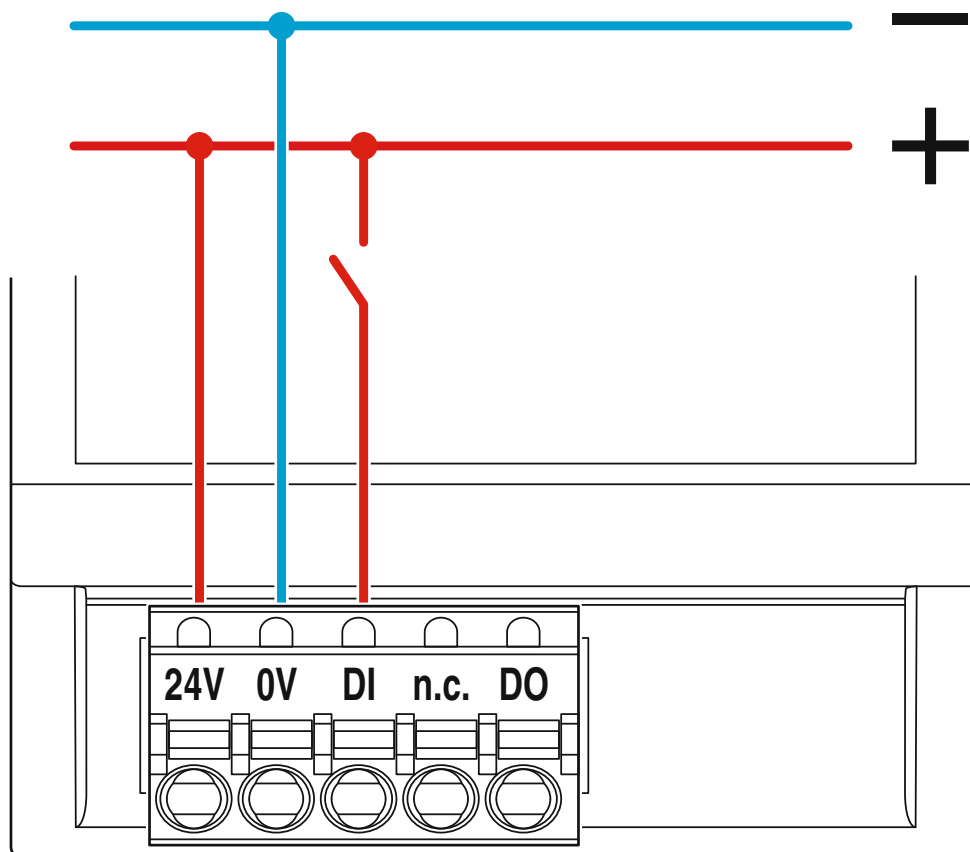

Connection diagram



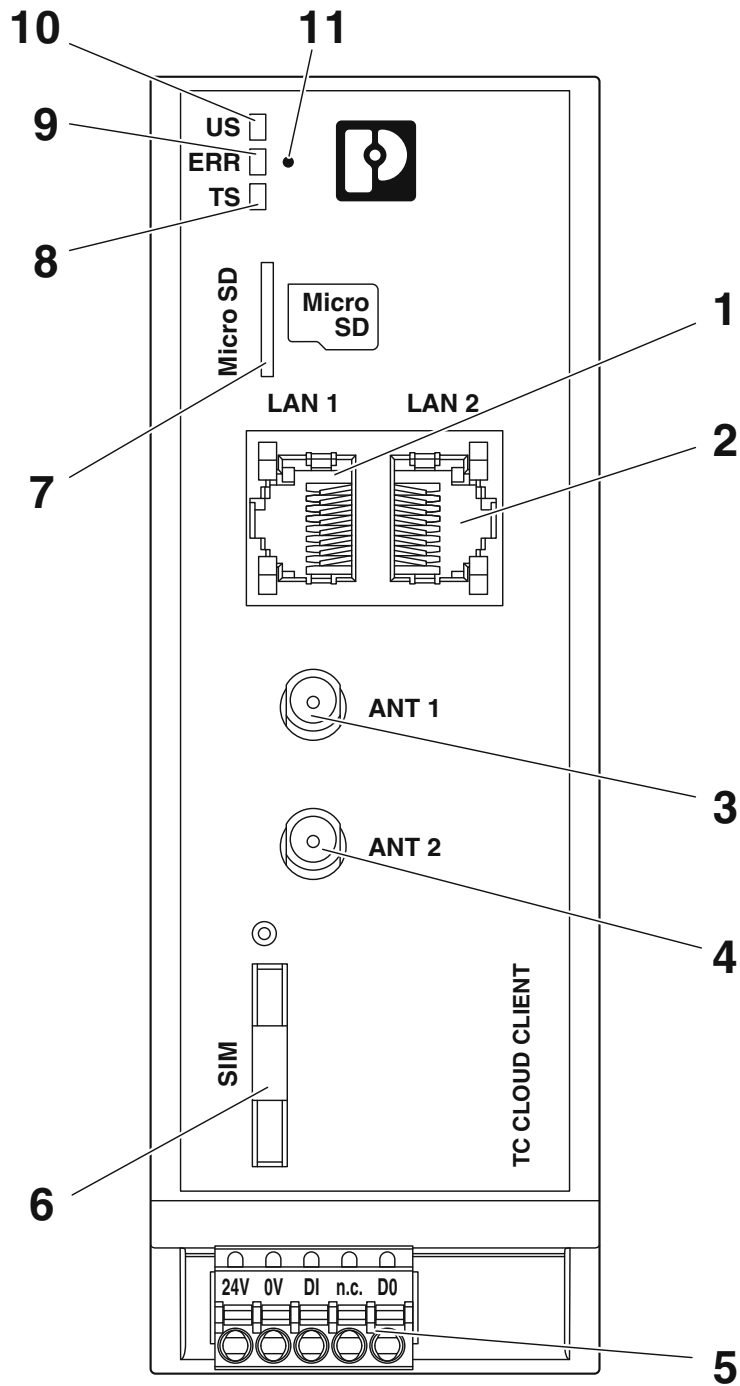
Switching input and switching output

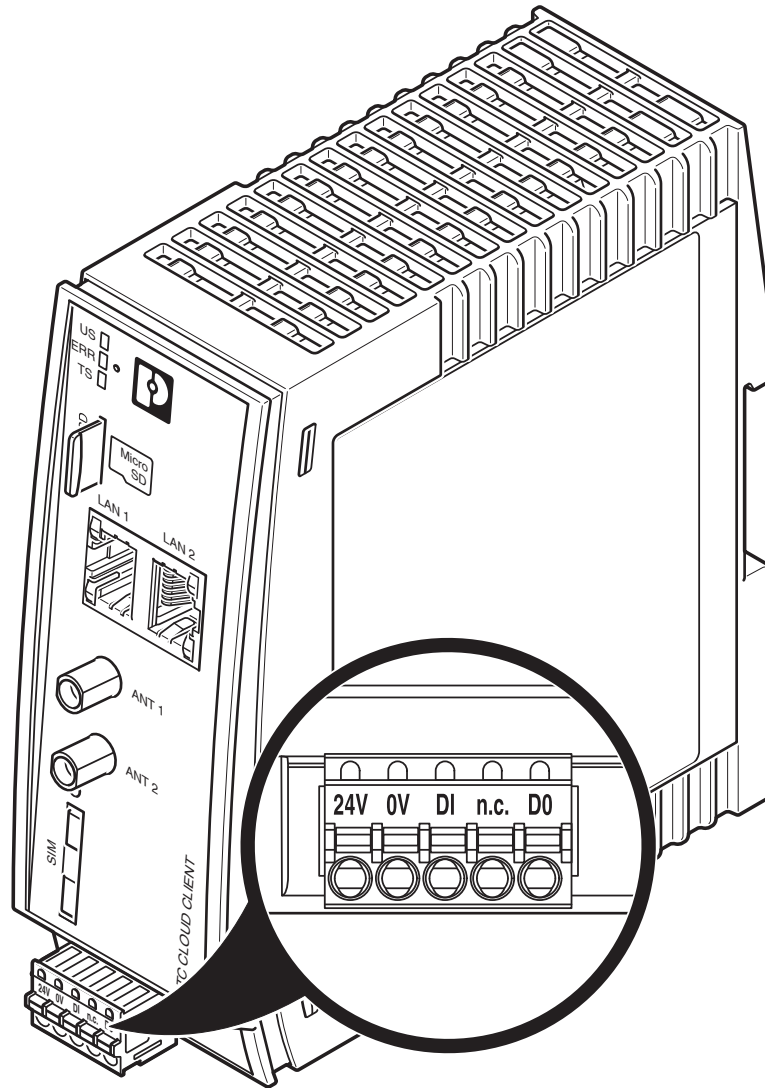

Schematic diagram



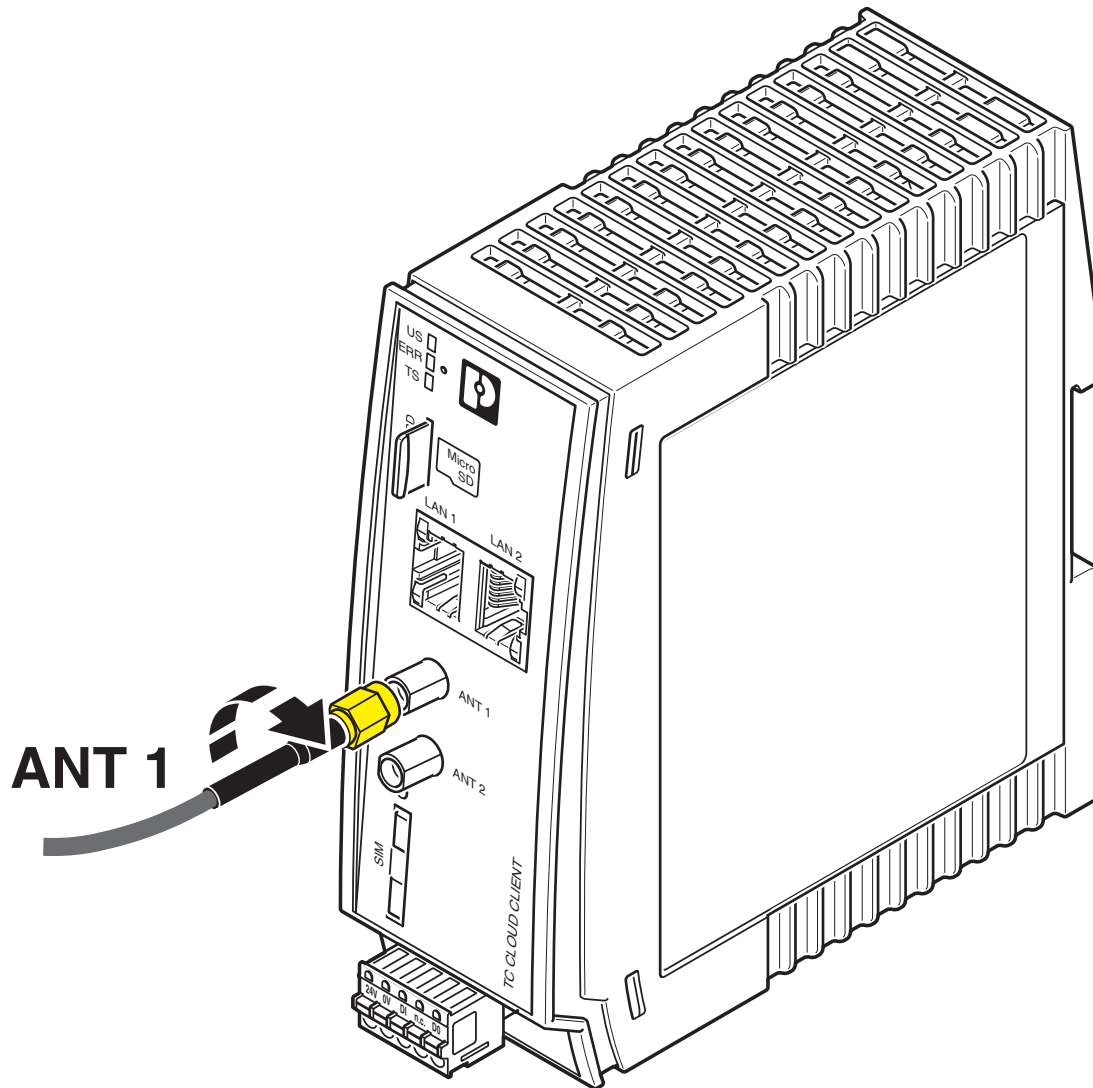
Connecting the supply voltage

Connect the antenna

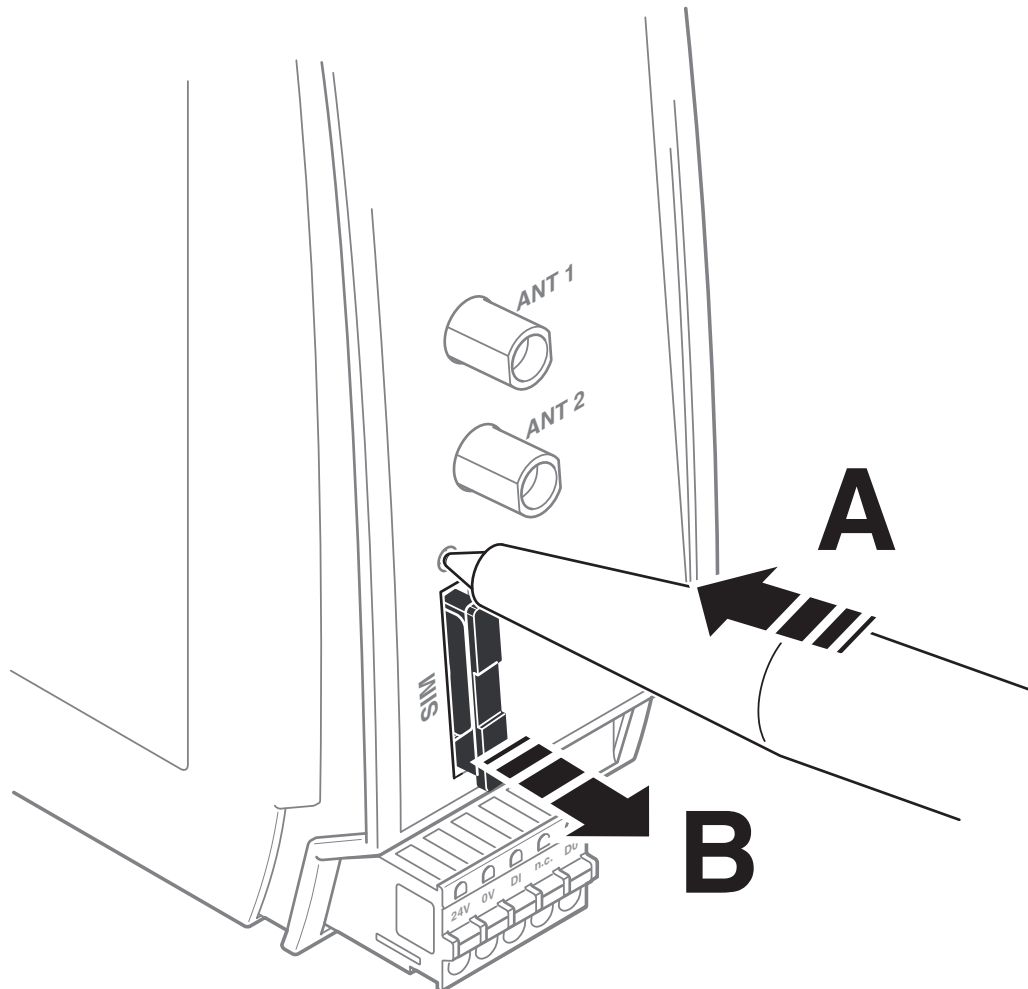

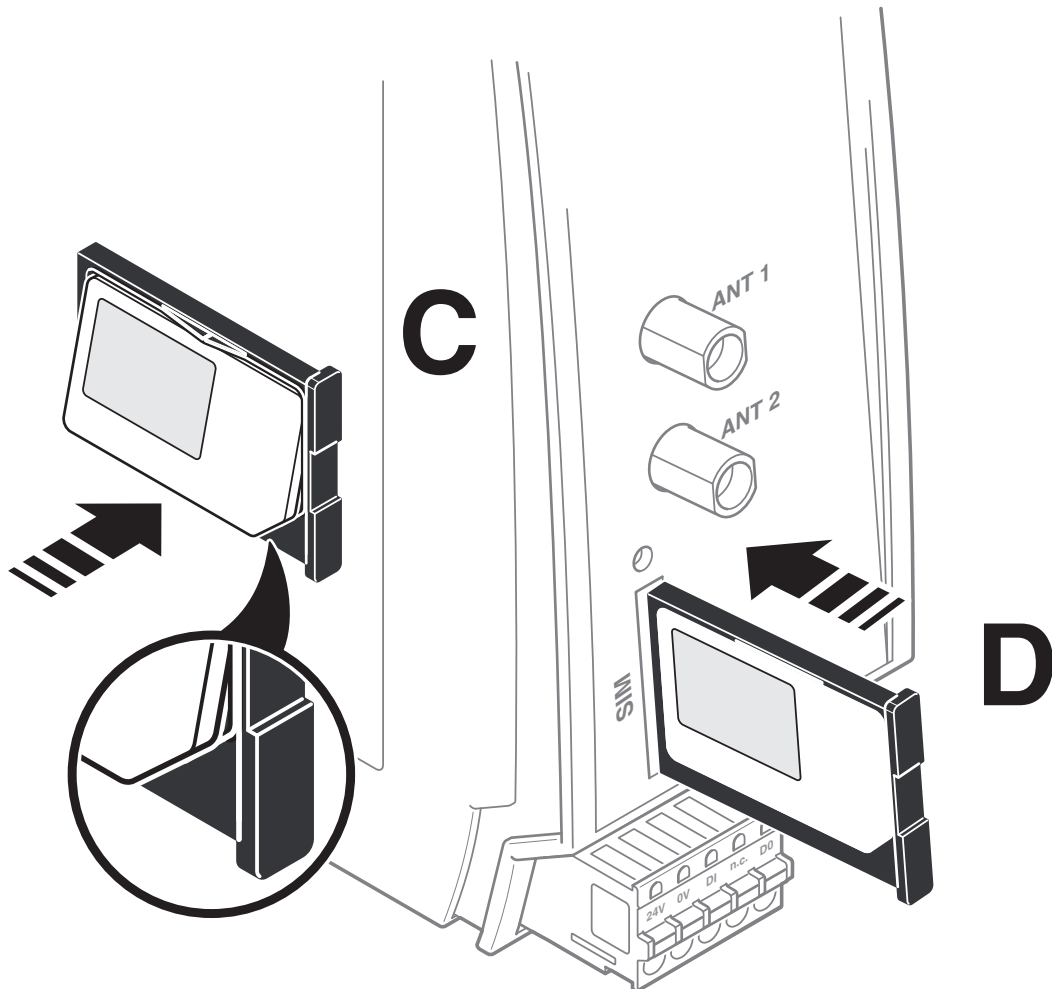
