Wiring diagram

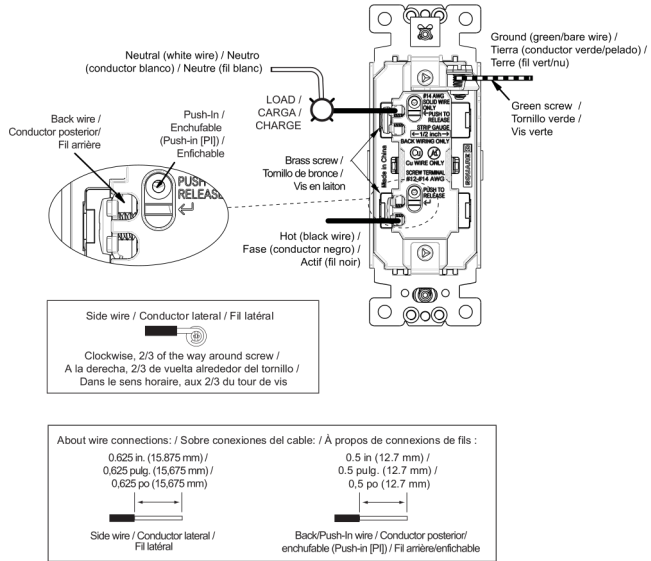
